Legislation Adapted as of 1/29/2013

*** Please note the SGA Senate passed the following Resolutions to amend the SGA Constitution

effective for Spring 2014 Elections and future elections:

1. **RESOLVED**, Office of Mister & Miss A&T at the time of the election must be a rising senior having completed at least 90 Semester hours at the end of the Spring Semester, be enrolled as a full time student, maintained a cumulative grade point average of 2.75 and completed 80% of his/her attempted coursework. During his/her reign must reside on campus, remain a fulltime undergraduate student, and maintain a cumulative grade point average of 2.75. Failure to maintain any listed item will result in removal from office. He/she must not be on disciplinary probation. He/she may serve a maximum of one (1) term.
2. **RESOLVED**, The forum for Miss and Mister A&T will now become a pageant. The pageant for Miss A&T and Mr. A&T shall be held before elections. Contestants will compete in Interview or Oratorical Speech, Talent, and Evening Wear with an on stage question. A panel of well-qualified judges from an array of different backgrounds will judge each contestant. They will be elected based on the following criteria:

3. **RESOLVED**, The top three candidates vying for the title of Mister & Miss A&T with the highest score from the pageant will then be placed on the ballot for the student body to vote. The candidate with the majority vote (50%+1) from the general elections results will be crowned the next Mister & Miss A&T.
