### **CHANCELLOR OVERSIGHT AND GOVERNANCE FOR THE DEPARTMENT OF INTERCOLLEGIATE ATHLETICS**

#### **UNIVERSITY POLICY**

The Chancellor at North Carolina Agricultural and Technical State University shall have the following supervisory, administrative and oversight responsibilities for the Department of Intercollegiate Athletics, as outlined in *The Code and UNC Policy Manual Chapter 1100.1 Intercollegiate Athletics*.

The Chancellor shall ensure:

1. That all athletes admitted to North Carolina A&T are capable of progressive academic success and graduation within six years;
2. That the policies for admission of student athletes are reviewed by appropriate members or bodies of the faculty and that any recommendations or advice from those members or bodies are received and considered;
3. That exceptions or waivers for the admission of student athletes are reviewed by appropriate members or bodies of the faculty and that any recommendation concerning these applicants are received and considered in a timely manner;
4. That student athletes follow a coherent course of study that is designed to maintain reasonable progress toward a baccalaureate degree;
5. That the tutorial and remedial academic programs for student athletes are administered by appropriate academic offices in cooperation with athletics department officials;
6. That athletes who are not making satisfactory academic progress are not allowed to continue as team players;
7. That a mandatory drug-testing program for student athletes is implemented and monitored;
8. That a formal awareness program on the dangers of gambling in athletics is implemented;
9. That North Carolina A&T conforms with NCAA standards;

10. That all foundations, clubs, and associations established primarily to raise money on behalf of North Carolina A&T Department of Intercollegiate Athletics are audited annually and that these audits are reviewed by the Board of Trustees and forwarded to the President;
11. That the Director of Athletics is not the coach of any sport;
12. An annual report is submitted to the Board of Trustees, with a copy to the President, in a manner consistent with the provisions of North Carolina A&T State University Policy [xxxxx] *Annual Report from the Chancellor's Council on Intercollegiate Athletics*;
13. That the annual report is forwarded to appropriate members or bodies of the faculty and that any response from such members or bodies is received and considered by the Chancellor;
14. That the athletically related financial information required by and reported to the National Collegiate Athletic Association, the U.S. Department of Education, and the Board of Governors through applicable University policy and regulations including, but not limited to, the financial information contained in the Equity in Athletics Disclosure Act Report and in the NCAA Operating and Capital Financial Data Report is reviewed and approved by appropriate institutional officials; and
15. That the annual budget for intercollegiate athletics is reviewed and approved by appropriate institutional officials, to include a review of primary sources of revenue and expenses, athletically related student fee data, including the institution's current athletics student fee and the percentage of student fee revenue as a share of total operating revenue for athletics, and any other relevant financial reports pertaining to the operation of the institution's intercollegiate athletics program.
